"Mrs. Margarette Allen, widow of Elisha Allen, died at the residence of her son-in-law Mr. T. J. Denson. Buried in Bartlett Cemetery with Rev. Walker officiating. She had lived in the vicinty of Bartlett many years. Indeed, she lived here many years before Bartlett was born. Survived by three children Mrs. Tom Denson, Mrs. Jack Phillips, and John M. Allen. Four sons George, William, Elijah, and Sam and one daughter Mrs. Ed Laughlin and her husband preceded her in death."

"Mr. Allen came to Washington County the year of its organization in 1848. He having come to Texas from Louisiana about 1832. He settled near Granger. A few years later he moved to Indian Creek and his home there is a landmark of this section. The heavy material and doors of this house are of cedar and were hauled overland by ox wagons from Jefferson, Texas a distance of over 200 miles. Mr. Allen not only had the pionee spirit but was imbued with patriotism. It was he who built the first neighborhood church and school house in his pasture and the little church was presided over in late years by Rev. J. M. Robinson, the father of Judge John D. and Hosaier Robinson and our townsmen Luther and T. P. Robinson. The present Presbyterian Church of this city grew from this little band and is under the same charter. The first teacher of this little school was Miss Susan Roberson afterwards Mrs. G. A. Allen, the mother of our present popular sheriff, Mr. Lee O. Allen of Georgetown. The student body of this school was made up of little Allens, Gillilands, and Stocktons."
